



Privacy notice and information on the processing of personal data in VIZA-system

After September 1, 2021, in accordance with the legislation in force, in Hungary personal data of recipients of accommodation services specified by law are recorded by the accommodation service provider in its accommodation management software via a document reader, and are stored in the Guest Information Closed Database (VIZA).

The accommodation provider, as data controller, records the following data of the user in its accommodation management software upon check-in, in order to protect the rights, safety and property of the data subject and others, and to monitor compliance with the provisions on the stay of third-country nationals and persons enjoying the right of free movement and residence:

- surname and first name;
- surname and given name at birth,
- place of birth,
- date of birth,
- sex;
- nationality;
- mother's maiden name and surname
- identity or travel document identification data;
- in the case of a third-country national*, visa or residence permit number, date and place of entry.

*third-country national: persons as defined in Act II of 2007 on the entry and residence of thirdcountry nationals.

The accommodation user presents the identification document to the accommodation provider for the purpose of recording the data.

Data which are not contained in the document shall not be recorded. **Failure to present the document shall result in the accommodation provider refusing to provide the accommodation. By law, the accommodation provider is entitled to request the guest's identity document and the guest is obliged to present it.**

Data Controller: City Resort Korlátolt Felelősségű Társaság

Data Processor: Hungarian Tourism Agency

The purpose of data processing: to protect the rights, safety and property of the data subject and others, and to monitor compliance with the provisions on the residence of third-country nationals and persons enjoying the right of free movement and residence.



Legal basis for processing: fulfilment of a legal obligation to which the controller is subject (Article 9/H of Act CLVI of 2016)

Duration of data processing: the accommodation provider processes the data of the users until the last day of the year following the day on which the data are made available to the accommodation provider for the purposes laid down by law. The data stored in the VIZA-system via asymmetric encryption may be searched by the police for the purposes of law enforcement, crime prevention, protection of public order, public security, public order at the state border, protection of the rights, safety and property of the data subject and others, and the conduct of wanted persons proceedings.

Rights of the Data Subject in relation to data processing

- a) the right to prior information,
- b) the right to rectification,
- c) right of access
- d) right to rectification
- e) the right to erasure, blocking or restriction, except for mandatory processing.

Regarding the lawfulness of the processing of Your personal data by the accommodation, You may initiate the procedure of the Hungarian National Authority for Data Protection and Freedom of Information (abbreviated name: NAIH)
